
**MEMORANDUM OF UNDERSTANDING
BETWEEN
CATUR INSAN CENDEKIA UNIVERSITY (UCIC), INDONESIA
AND
AFRICAN INSTITUTE FOR MULTIDISCIPLINARY STUDIES (AIMS), SOMALIA

This Memorandum of Understanding (MOU) is entered into on 9th September 2024, between Catur Insan Cendekia University, located at Jl. Kesambi No. 202, Drajat, Cirebon City, West Java, Indonesia, and the African Institute for Multidisciplinary Studies (AIMS), located at 28P7+M66, Taleex, Road, Muqdisho, Somalia.

PREAMBLE

WHEREAS, both UCIC and AIMS are committed to promoting academic excellence, research, and community engagement in their respective regions;

WHEREAS, both institutions recognize the importance of international collaboration to enhance the quality of education, research, and community service;

WHEREAS, both institutions are interested in fostering a mutually beneficial partnership to facilitate student exchanges, research and community service collaboration, and academic collaboration in seminar, workshop, guest lecture, and conferences.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

ARTICLE I: STUDENT EXCHANGE

- 1.1 UCIC and AIMS agree to promote student exchange programs that provide students with the opportunity to study and engage in cultural experiences at each other's institutions.
- 1.2 The duration and terms of student exchange programs shall be determined by mutual agreement between UCIC and AIMS, ensuring that participating students adhere to the academic and administrative regulations of the host institution.

ARTICLE II: RESEARCH AND COMMUNITY SERVICES COLLABORATION

- 2.1 UCIC and AIMS will promote research collaboration between their faculty members and researchers in various academic disciplines.
- 2.2 Researchers from both institutions may collaborate on joint research projects, publications, and grant applications, as mutually agreed upon.
- 2.3 UCIC and AIMS recognize the importance of community service and social responsibility. Both institutions will collaborate on community service projects in their respective regions.
- 2.4 Joint community service initiatives may encompass technology, economy, business, educational outreach, healthcare programs, and other activities aimed at improving the well-being of the communities served by UCIC and AIMS.

ARTICLE III: ACADEMIC COLLABORATION

- 3.1 Both institutions commit to promoting academic collaboration in benchmarking institution's vision and mission, and curriculum review for study program.
- 3.2 Both institutions may collaborate on seminars, workshops, guest lecture, and conferences organized by UCIC and AIMS.
- 3.3 Collaboration opportunities may include delivering lectures, presentations, or workshops on subjects of mutual interest and academic significance.

ARTICLE IV: IMPLEMENTATION AND RESPONSIBILITIES

- 4.1 UCIC and AIMS shall appoint coordinators responsible for overseeing the implementation of this MOU and facilitating communication between the two institutions.
- 4.2 Both institutions shall cooperate in securing the necessary resources, including financial support and logistics, to ensure the success of the activities outlined in this MOU.

ARTICLE V: DURATION AND AMENDMENTS


- 5.1 This MOU shall be effective upon the date of its signing and remain in force for a period of 3 years.
- 5.2 This MOU may be amended or extended by written agreement of both institutions, with any modifications recorded in writing.

ARTICLE VI: GOVERNING LAW

- 6.1 This MOU shall be governed by and construed in accordance with the laws of the respective countries of UCIC and AIMS.


